Date	Action
July 14, 2003	Filing period for Declaration of Candidacy and Nomination Document opens.
July 31, 2003	Semi-annual FPPC Statement due for period ending 6/30/03.
August 8, 2003	Filing period for nomination documents closes. If an incumbent fails to file, that office's filing period shall be extended five calendar days.
August 13, 2003	Extension period closes for filing nomination documents for specific offices in which no incumbent filed.
August 14, 2003	The Secretary of State shall conduct the randomized alphabet drawing at 11:00 a.m.
September 8, 2003	Filing period for Statements of Write-In Candidacy opens.
September 25, 2003	Pre-election FPPC Statement due for period ending 9/20/03.
October 19 - November 3, 2003	Reports of Late Contributions and Late Independent Expenditures of \$1,000 or more to a single source due within 48 hours of receipt or expenditure.
October 21, 2003	Filing period for Statements of Write-In Candidacy closes.
October 23, 2003	Pre-election FPPC Statement due for period ending 10/18/03.
November 4, 2003	Election Day
November 24, 2003	Last day for the Registrar of Voters to certify election results.
